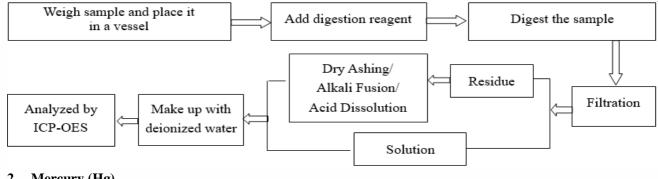

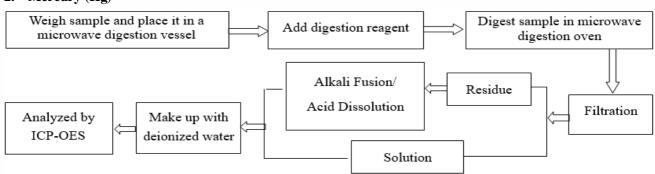

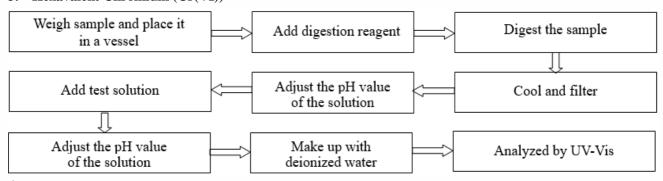
#### 1. Lead (Pb), Cadmium (Cd), Chromium (Cr)



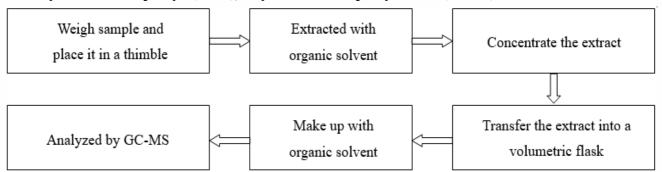
#### 2. Mercury (Hg)



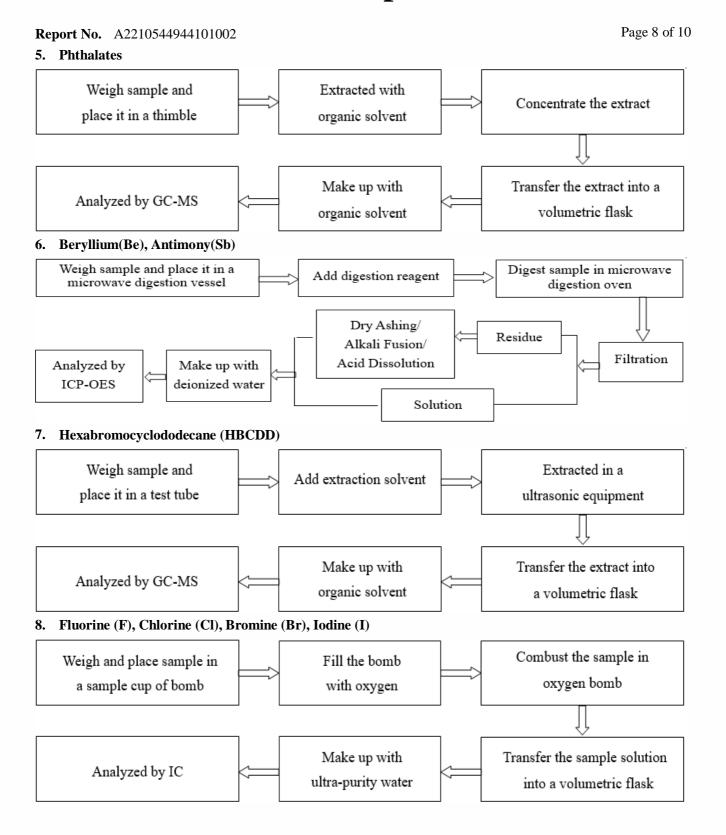
#### 3. Hexavalent Chromium (Cr(VI))



#### 4. Polybrominated Biphenyls (PBBs), Polybrominated Diphenyl Ethers (PBDEs)





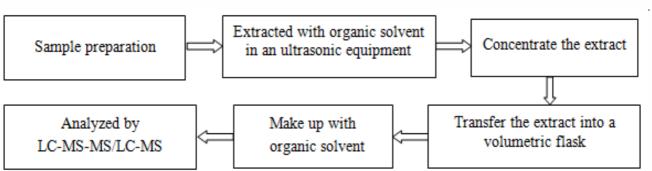

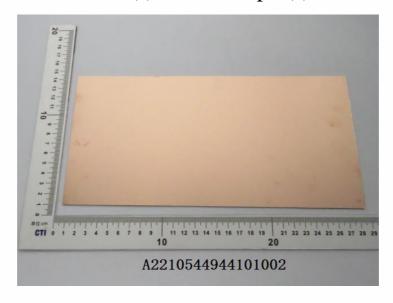
