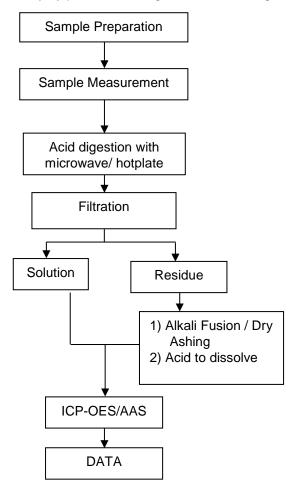

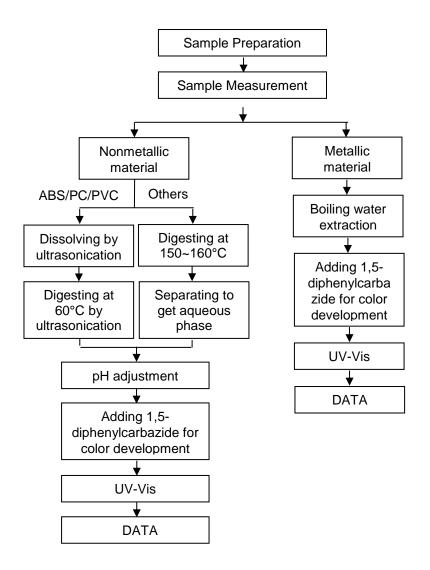

Hexavalent Chromium (Cr(VI)) Testing Flow Chart





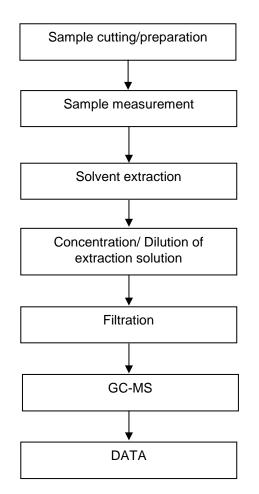

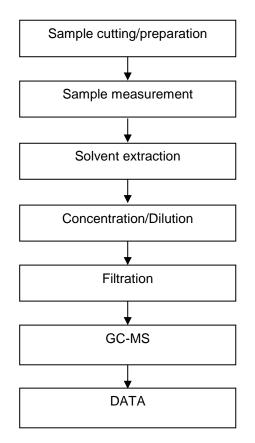

#### **Phthalates Testing Flow Chart**





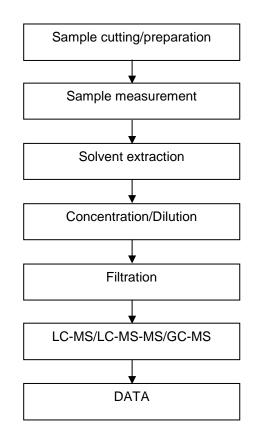

### **PFASs/ PFOS/PFOA Testing Flow Chart**





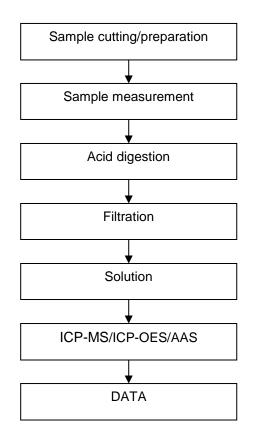

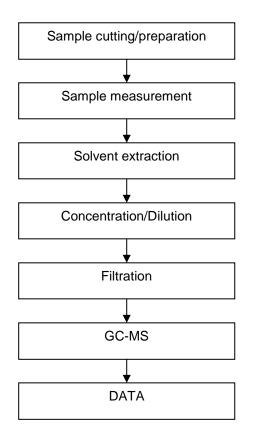
